Thayer Distribution reserves the right to revoke credit or refuse further credit sales at any time for any reason or for no reason, without notice to customer. Thayer Distribution will not ship to any account with an unpaid invoice outstanding for thirty days or more. Thayer Distribution will not deliver an order and pick up a delinquent check.

## 8. Finance Charge

A finance charge equal to the lesser of 1½% per month (18% per annum) or the highest allowable rate under New Jersey law will be charged on all past due accounts. Applicant agrees to pay such finance charge and all reasonable collection costs, including legal fees and expenses, in case of any action for non-payment of any invoice.

## 9. Limitation of Liability

In no event shall Thayer Distribution ever be liable to Applicant or its subsidiaries, affiliates, franchisees or operators, for any type of consequential, incidental, indirect or special damages, including, but not limited to, loss of profits or business opportunities, whether or not any such liability or damages shall be based upon breach of contract, tort (including negligence, gross negligence or strict liability) or otherwise, whether or not Thayer Distribution has been advised of the possibility of such losses, and whether or not any limitation on Applicant's remedies is deemed to fail in its essential purpose. All such excluded damages are expressly waived. Thayer Distribution hereby rejects any additional or different terms in any purchase order or other communication from Applicant.
